

COMPETITOR ADMISSION AGREEMENT

THIS COMPETITOR ADMISSION AGREEMENT (hereinafter, the "**Agreement**") is entered into on the latest of the date(s) listed on the last page of this Agreement (hereinafter, the "**Effective Date**") by and between **PARTY HELPERS, LLC** and the following "**COMPETITOR**":

For purposes of this Agreement, **PARTY HELPERS, LLC** and **COMPETITOR** may sometimes be jointly referred to as the "Parties," or separately referred to as a "Party."

WITNESSETH:

WHEREAS, PARTY HELPERS, LLC is the organizer of **CHARLESTON AREA FOOD EXPO**, which is a trade show of food, beverage, and general hospitality service providers in the greater Charleston area;

WHEREAS, as a part of **CHARLESTON AREA FOOD EXPO, PARTY HELPERS, LLC** will hold competitions in various categories related to the food services and hospitality industry; and

WHEREAS, COMPETITOR wishes to compete in one of the competitions; and

NOW, THEREFORE, in consideration of the mutual covenants and benefits provided for in this Agreement, the receipt and sufficiency of which are hereby acknowledged by the Parties, the Parties agree as follows:

1. CHARLESTON AREA FOOD "EXPO"

CHARLESTON AREA FOOD EXPO (hereinafter, the "**EXPO**") is a trade show of food, beverage, and general hospitality service providers in the Charleston area, and is intended to be a forum where Participants can demonstrate and advertise their services, as well as to learn from other Participants.

The **EXPO** will take place at the **OMAR SHRINE AUDITORIUM** (hereinafter, the "**OMAR AUDITORIUM**"), 176 Patriots Point Road, Mt. Pleasant, South Carolina 29464, from February 6, 2010 through February 7, 2010. The actual **EXPO** will take place from 11:00 a.m. to 8:00 p.m. on February 6, 2010, and 12:00 p.m. to 5:00 p.m. on February 7, 2010.

2. COMPETITION CATEGORIES

The following list sets forth the different competition categories that will be featured at the EXPO. **COMPETITOR** hereby requests admission as a contestant in the competition marked by an "X" below:

<p>COMPETITOR MUST MARK "X" BY ONE OF THE FOLLOWING BOOTHS</p> <p style="text-align: center;"><u> </u> ICE CARVING. ENTRY FEE: \$50.00</p> <p>All COMPETITOR involved in the Ice Carving Competition will begin with one 300# block of ice, to be provided by PARTY HELPERS, LLC. Each COMPETITOR must provide their own carving tools for the Ice Carving Competition; PARTY HELPERS, LLC will not provide such materials. Permissible carving tools include one electric chain saw and any assortment of chisels. A theme for the Ice Carving Competition will be provided to COMPETITOR immediately before the contest begins. COMPETITOR will have thirty (30) minutes to design and complete their sculptures. WINNER \$300 - 150 - 75</p> <p style="text-align: center;"><u> </u> SHRIMP & GRITS EATING COMPETITION ENTRY FEE: \$10.00</p> <p>All COMPETITOR involved in the SHRIMP & GRITS EATING COMPETITION must be over the age of Eighteen (18) and provide a SC Drivers License to prove eligibility. Each COMPETITOR will be given ten (10) minutes to consume as many bowls of SHRIMP & GRITS as possible. NOTE: All bowls will be weighed to determine that each COMPETITOR receives the exact amount of SHRIMP & GRITS. At the end of ten (10) minutes, the number of bowls for each COMPETITOR will be tallied and all partial bowls will be weighed to determine the winner. WINNER \$300 - 150 - 75</p>

By marking an "X" by one or more of the selections in the above box, **COMPETITOR** agrees to pay the designated Competition Admission Fee to **PARTY HELPERS, LLC**, as outlined below.

3. COMPETITION ADMISSION PRICES

A. Admission Fee for the ICE CARVING COMPETITION is and FIFTY and 00/100 (\$50.00) Dollars. **COMPETITOR** shall make payments for admission to **PARTY HELPERS, LLC**.

B. Admission Fee for the SHRIMP & GRITS EATING COMPETITION is and TEN and 00/100 (\$10.00) Dollars. **COMPETITOR** shall make payments for admission to **PARTY HELPERS, LLC**.

The Admission Fee outlined above allows **COMPETITOR** to participate in the competition categories marked with an "X" above, and includes the costs indicated in the above descriptions. The Admission Fee does not, however, include the following: for the Ice Carving Competition, the Admission Fee does not include any carving tools or materials;

D. Cancellations; Refunds.

Any **COMPETITOR** may cancel his/her/its reservation for admission to one or more competitions at the **EXPO** prior to January 20, 2010. If **COMPETITOR** cancels prior to January 20, 2010, the Admission Fee paid by Competitor to **PARTY HELPERS, LLC** will be refunded. **COMPETITOR** who cancel after January 20, 2010 will not be entitled to a refund of the Admission Fee.

4. RESPONSIBILITIES OF COMPETITOR ONLY TO ICE CARVING

In connection with participation in the **EXPO**, **COMPETITOR** shall have the following responsibilities:

- A. Payment of the Admission Fee, if required, as outlined above;
- B. Setting up and preparing for the **EXPO**, during the hours of 2:00 p.m. to 3:00 p.m. on February 6, 2010;
- C. Packing up and removing all items from the premises after the **EXPO** from 6:00 p.m. to midnight on September 10, 2006. **PARTY HELPERS, LLC** shall have no responsibility for **COMPETITOR** failure to remove items from the **OMAR AUDITORIUM** during that time, and shall have no responsibility for any lost items resulting from the same.

Any and all costs incurred by **COMPETITOR** in satisfying these requirements shall be the sole responsibility of Competitor.

5. ADDITIONAL RULES

The following rules and regulations shall apply to **COMPETITOR** with regard to participation in the **EXPO**:

A. **COMPETITOR** must abide by any rules or guidelines provided by the management of the **OMAR AUDITORIUM**.

B. **WAIVER OF LIABILITY AND INDEMNITY** ~ **PARTY HELPERS, LLC** will exercise reasonable precautions for the protection of property of **COMPETITOR** but shall assume no responsibility for loss and/or damage to the property of **COMPETITOR** placed in exhibit area or adjacent grounds and is discharged from all responsibilities. It is understood and agreed by the **COMPETITOR** that **PARTY HELPERS, LLC** may cancel said **EXPO and Competitions**, and may cancel this **AGREEMENT** if in the opinion of **PARTY HELPERS, LLC** such **EXPO and Competitions** would be impractical and/or inadvisable to continue due to lack of participation by **COMPETITOR** .

PARTY HELPERS, LLC reserves the right to amend, modify or add to these Rules at any time prior to or during the **EXPO**, and **COMPETITOR** hereby agrees to abide by any such amendments, modifications, or additions to the Rules.

4. INSURANCE

It is the responsibility of each **COMPETITOR** to purchase insurance coverage, if necessary.

5. COMPETITOR PASSES

One (1) pass will be issued to each **COMPETITOR** and must be worn to enter into the competition area and all times thereafter. If the **COMPETITOR** pass is lost or misplaced, then a new pass will be reissued at a charge of \$1.00 from **PARTY HELPERS, LLC**. The lost or misplaced pass will be deactivate so it cannot be used by someone other than the **COMPETITOR** it was issued too.

6. LIMITATION OF LIABILITY

PARTY HELPERS, LLC shall have no responsibility for any injury or damage to person or property regarding **COMPETITOR** participation in any aspect of the **EXPO**, including **COMPETITOR** participation in any of the competitions outlined above. It is **COMPETITOR** obligation to safeguard his/her/its own property and person and to ensure that the same is removed from the **OMAR AUDITORIUM** in accordance with the time guidelines set forth above, and **COMPETITOR** understands that failure to do so may result in a loss, which he/she/it shall bear, at no cost or expense to **PARTY HELPERS, LLC**. **COMPETITOR** assumes any and all risks associated with participation in the **EXPO**, including any and all risks associated with competing in any of the competitions outlined above, and will hold harmless **PARTY HELPERS, LLC** for any injury or damage caused thereby. In addition, **COMPETITOR** agrees to hold harmless and indemnify **PARTY HELPERS, LLC** for any injury or damage caused to person or property for which **PARTY HELPERS, LLC** is held liable if such injury or damage is proximately caused by **COMPETITOR** actions or failure to act.
